IN FY-14 MONTGOMERY CARES PROVIDED MORE THAN 76,000 OUTPATIENT VISITS TO ALMOST 29,000 PATIENTS, COORDINATED NEARLY 2,700 SPECIALTY CARE VISITS AND SECURED \$1.3 MILLION IN DONATED HOSPITAL AND PHYSICIAN SERVICES.
